CACFP in Maryland: Outreach & Referral Toolkit



The Child and Adult Care Food Program (CACFP) is a federal nutrition program that provides funds for meals and snacks served to eligible children at child care centers and homes.

Building Better Beginnings (B3) and the Food Research & Action Center (FRAC) have developed a communications toolkit to help Child Care Resource Center (CCRC) staff and other early childhood stakeholders increase their knowledge of CACFP in Maryland and effectively promote CACFP to eligible child care providers. The toolkit provides background information on CACFP as well as outreach materials and templates to communicate with Maryland child care providers within the state that may be eligible for CACFP and unaware of the program.

I. Fundamentals of CACFP

What is CACFP?

The Child and Adult Food Program (CACFP) is a federal nutrition program that pays for nutritious meals and snacks served to eligible children who are enrolled at participating child care centers, family child care homes, afterschool programs, and emergency shelters.

How does it work?

USDA's Food and Nutrition Service (FNS) administers CACFP through grants to states. In Maryland the program is administered by the Maryland State Department of Education. Early childhood education centers and/or child care homes enter into an agreement with the Department of Education to assume administrative and financial responsibility for CACFP operations. Centers and child care homes may be approved to claim up to two reimbursable meals (breakfast, lunch or supper) and one snack, or two snacks and one meal, to each eligible participant, each day. CACFP works slightly differently based on whether you are a child care center or home.

The Tier of the child care home is determined by where they are located.

What are the benefits of CACFP?



Financially, in Maryland a child care center could be reimbursed up to \$41,340 annually for serving 25 free-eligible participants breakfast, lunch, and a PM snack 5 days a week. A family child care home could be reimbursed up to \$7,456 annually for serving 6 participants breakfast, lunch and a snack, 5 days a week.

How does a provider participate in CACFP?

Getting started with CACFP is easy. The process for participating is a little different between child care centers and child care homes.

Child Care Centers

Child Care Centers can either participate directly through the Maryland State Department of Education (MSDE) or through a sponsoring organization that will help facilitate their participation in the program. For a child care center that would like to use a sponsoring organization they can find a sponsor by visiting <u>info.cacfp.org/sponsor</u>. Or contact one of the following CACFP sponsors of centers.

If a child care center would like to participate in CACFP independently they can start by calling the Maryland State Department of Education at 410-767-0199, which will then determine the center's eligibility for the program. If assessed to be eligible for CACFP the Department of Education will then create a user account for the center where the center will submit the agency application. Once approved by the Department of Education, center staff will attend CACFP orientation training after which they will submit program and site applications to the Department of Education. Maryland State Department of Education evaluates the center's readiness to begin claiming meals and will review the center's compliance during the first year. Child Care Homes

II. Talking Points for CACFP Frequently Asked Questions

Basics of the Child Care and Adult Food Program (CACFP)

- What is CACFP?
 - Sometimes referred to as the "Food Program"
 - Federal nutrition program that pays for nutritious meals and snacks for eligible children
 - Meals and snacks must comply with the United States Department of Agriculture (USDA) nutrition standards and meal patterns
 - Eligible children are enrolled at participating child care centers, family child care homes, afterschool programs, and emergency shelters.
 - Can claim up to two reimbursable meals (breakfast, lunch or supper) and one snack, or two snacks and one meal, for each eligible participant per day

What are the qualifications to participate in CACFP?

- ➤ Early childcare education centers:
 - Can participate independently or use a food program sponsor that will help the center navigate CACFP.
 - For profit centers must receive title XX funds for at least 25 % of enrolled children or licensed capacity (whichever is less) or
 - 25 % of the children in care must be eligible for free and reduced price meals
 - Reimbursement rates are based upon a child's eligibility for free, reduced price, or paid meals
- > A family or group child care home:
 - Must sign an agreement with a sponsoring organization to participate in CACFP.
 - The home must be licensed or approved to provide child care services.
 - Reimbursement for meals is based upon eligibility for tier I rates (which targets higher levels of reimbursement to low-income areas, providers, or children) or lower tier II rates
 - Tier I:
 - located in low-income areas or
 - The provider's household income is at or below 185 percent of the Federal income poverty guidelines
 - May use elementary school free and reduced price enrollment data or census block group data to determine which areas are low-income.
 - Tier II:
 - Family child care homes that do not meet the location or provider income criteria for a tier I home.

 may elect to have the sponsor organization identify income-eligible children, so that meals served to those children who qualify for free and reduced price meals would be reimbursed at the higher tier I rates

What are the financial benefits of CACFP?

- ➤ For a Child Care Center:
 - Reimbursement of up to \$41,340/year for serving 25 free-eligible participants Breakfast, Lunch, and a snack 5 days a week
- ➤ For a Family Child Care Home:
 - Reimbursement of up to \$7,456/ year for serving 6 Tier I participants breakfast, lunch and a snack, 5 days a week.

- Independently participating:
 - Call the Maryland State Department of Education at 410-767-0199, which will then determine the center's eligibility for the program.

- If assessed to be eligible for CACFP the Department of Education will then create a user account for the center
- Center will submit the agency application
- Once approved by the Department of Education, center staff will attend CACFP orientation training
- Center will submit program and site applications to the Department of Education
 - Which will evaluate the center's readiness to begin claiming meals
 - Center's compliance will be reviewed during the first year

1. Email Template for Child Care Homes

Did you know that Child Care Homes like yours can receive funds for meals and snacks served to children in your care?

The Child and Adult Care Food Program (CACFP) is a federal nutrition program that pays for nutritious meals and snacks served to eligible children who are enrolled at participating child care centers, family child care homes, afterschool programs, and emergency shelters.

A child care home can claim up to two reimbursable meals (breakfast, lunch or supper) and one snack, or two snacks and one meal, for each child per day. CACFP improves participants' nutrition and health, promotes healthy growth, strengthens the quality of early care, helps boost and stabilize child care providers' income and services, reduces food insecurity, boosts learning and development and stimulates the local economy. Financially, in Maryland a child care home could be reimbursed up to \$7,456 per year for serving 6 children breakfast, lunch and a snack, 5 days a week.

In Maryland, child care homes must work with a sponsoring organization to participate in CACFP and need to be licensed or approved to provide child care services. The reimbursement rate for meals is based upon your location, which determines eligibility for tier I rates (the higher rate) or lower reimbursement rates at tier II.

In order to qualify for profit centers must receive title XX funds for at least 25 percent of enrolled children or licensed capacity (whichever is less) or at least 25 percent of the children in care must be eligible for free and reduced price meals. Meals served to children are reimbursed at rates based upon a child's eligibility for free, reduced price, or paid meals.
